This letter is the initial agency decision to your 9/23/17, request under the Freedom of Information Act (FOIA), 5 U.S.C. § 552, submitted to the VISN 4 FOIA Office for a copy of the list of persons and titles who had access to your Administrative Investigative Board (AIB). The Area Manager –VA Altoona Service Operations-End User Operations, Office of Information and Technology and the VISN 4 Privacy Officer conducted a search for documents responsive to list of persons and titles that had access to the Administrative Investigative Board (AIB) for the DeNofrio AIB investigation dated 12/18/2015 through 10/4/2016.
